CLÁUSULA PRIMEIRA – FUNDAMENTO LEGAL

1.1 No que se refere ao acréscimo ao contrato, fundamenta-se na solicitação feita pela unidade através do Memorando nº 023/2021 – HMAP, na manifestação favorável da Gerência de Controle Interno por meio do PARECER CI/IBGH - 165/2021; na cláusula 5ª, caput, no §2º do contrato e demais normas aplicáveis à matéria.

CLÁUSULA SEGUNDA – OBJETO

2.1 – o presente aditivo tem por objeto o acréscimo para que ocorra a prestação de serviços na central de esterilização de materiais hospitalares, locação de equipamento incluindo a manutenção e qualificação, fornecimento de mão de obra especializada e de insumos para atender às necessidades do Centro de Especialidades de Aparecida de Goiânia – HMAP – Extensão, devido ao cenário atual pandêmico da COVID 19 em que o número

de infectados vem aumentando exponencialmente, e conseqüentemente aumentou a necessidade de abertura de leitos para o atendimento de pacientes em estado crítico.

2.2 – Em função do acréscimo de 86 (oitenta e seis) leitos do Centro de Especialidades de Aparecida de Goiânia – HMAP – Extensão ao contrato 011/2020-HMAP, considerando o valor unitário por leito de R\$ 438,25 (quatrocentos e trinta e oito reais e vinte e cinco centavos), haverá um **aumento mensal estimado** de R\$ 37.689,50 (trinta e sete mil, seiscentos e oitenta e nove reais e cinquenta centavos), passando a ser pago à CONTRATADA o **valor mensal estimado** de R\$ 172.689,50 (setecentos e setenta e dois mil, seiscentos e oitenta e nove reais e cinquenta centavos).

CLÁUSULA TERCEIRA – DA VIGÊNCIA E DA CONVALIDAÇÃO

3.1 – O presente aditivo de acréscimo tem por termo inicial o dia **10 de março de 2021**, podendo, a qualquer tempo, caso o Município de Aparecida de Goiânia entenda pela não manutenção do Centro de Especialidades de Aparecida de Goiânia, ser suprimido do contrato 011/2020-HMAP, sem necessidade de aviso prévio e sem direito a qualquer indenização.

3.2 – Ficam ratificados e convalidados todos os atos praticados desde a data de 10 de março de 2021.


4.1 – Permanecem inalteradas todas as demais Cláusulas do Contrato nº 011/2020-HMAP e seus aditivos.

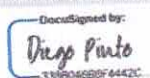

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Bioxxi Serviços de Esterilização Hospitalar (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
